

## Charlottesville Redevelopment and Housing Authority “CRHA” policies regarding the Coronavirus Disease (COVID-19)

---

### Effective Immediately

COVID-19 is a respiratory illness that can spread from person to person. Cases in the United States began in January 2020 and continue to increase. We are committed to doing everything we can to ensure the health and well-being of our housing program participants, our staff and the public while continuing to address the housing concerns of our community. Due to concerns during this pandemic, the CRHA has enacted the changes below.

### Changes to CRHA Operations for reducing person-to-person contact:

- Administrative offices are closed to public except by appointment, and then access will only be granted to the lobby area.
  - Staff will report to work at their regular scheduled work hours. Staff who are capable of completing their assigned tasks from home with concurrence from their supervisor will be encouraged to do so in order to improve social distancing and prevent community spread.
  - Employees that have been approved to work at home may have computer or other office equipment issued to them to complete necessary work activities only.
  - All Applications, Interim and Annual certification will be done without direct contact with staff. The packets will be mailed to families, with instructions on how to complete & return them.
  - Instructions for making income changes can be made by contacting you CRHA staff.
  - CRHA will be as flexible as possible with cut-off dates for accepting notice of COV19-related income decreases.
  - Documents and verifications (like pay stubs) may be emailed to your worker if you are comfortable doing so. We will accept screenshots and photos of documents on a temporary basis. Can't email, fax, or mail? Drop off your paperwork in the drop-box outside the Rental Office at 500 S First Street.
  - Photocopies will not be made at this time. Items can be mailed back upon request.
  - All HQS inspections on occupied units are being postponed. They will be conducted at a later date.
  - Work orders will only be completed in occupied units if life or safety issue.
  - **Rent statements will be mailed, NOT picked up in office.**
  - **Rent will be paid through the mail or placed in the drop box outside the Rental Office at 500 S. First Street, and receipts will be mailed. Please be sure that your name and apartment number are on the payment.**
  - While the CRHA will not be pursuing evictions during this State of Emergency due to failure to pay rent for tenants who are unable to pay rent due to circumstances related to the Coronavirus pandemic, residents are still responsible for making monthly payments.
  - CRHA is committed to assisting our residents with budgeting concerns and achieving stability. Should a resident need our assistance with life issues or need help or food, please contact CRHA staff.
